(iv) Credential Certificate in support of Agency's experience in the last three years in similar nature of work should be uploaded [WITH SELF ATTESTED].
7. Current Solvency Certificate of the amount of Rs. 10 Lakh/- form any Nationalised Bank shall have to be submitted.
8. The Agency should be registered under the Provident Fund Act, ESI Act, Labour Law and other relevant statutory enactments relating to the employment of labour. Copy of the registration papers along with code numbers attached to the Agency/Company shall be uploaded.
9. The Agency should have obtained a license from the controlling authority under Section 7(5) of "The Private Security Agencies (Regulation) Act, 2005 [No. 29 of 2005]". Copy of the same shall be uploaded. The Agency should preferably have an all India network.

10. The above rates are prepared in accordance with the current minimum wages as notified by the Govt. of West Bengal (SI No. i, ii, iii, iv, v & vii) and for Ex-serviceman rate would be quoted in accordance with the current minimum wages as notified by the Government of India.

11. That if any case the minimum rate of wages is restructured by the Govt. of W. B. the rate of the Guards mentioned in SI No. 1 also be restructured on the basis of minimum rates of wages of Govt. of W. B. and the difference of rates in respect of rates of respective manpower and its allied components like ESIC, EPF, Bonus, Service Charges etc. will be paid by the Council on the basis of claim raised by the Agency.

12. It may be noted that the tender notice is only for fixing a contract and shall not be constructed as invitation to bid for providing the job i.e. there is no guarantee for award of work without assigning any reason whatsoever may be.

13. The tenders who are confident of executing the contract in time by employing the required resources and manpower should only participate in this tender offer.

14. From eligible Firm/Agency holding valid license under Contract Labour (Regulation & Abolition) Act, 1970 for providing services of office upkeep and housekeeping job.

15. The Council reserves the right to reject any or all tenders without assigning any reasons whatsoever.
