Sub: Provisions offered for CWSN for forthcoming Semester- III (Higher Secondary Examination, 2027) as per RPWD Act, 2016

Sir/Madam,

With reference to the above, I am directed to inform that the Council has the following provisions for CWSN in tune with RPWD Act, 2016.

Provisions offered to the CWSN candidates by WBCHSE under RPWD Act, 2016 are noted below:

Sl No.	Classification of provision	Accommodations/Provisions offered by WBCHSE
1	Scheduling Provisions (Adjustment to the time allowance or scheduling of test through extended and/or compensatory time, breaks)	Allow extra time for completion of examination (20 minutes for or per hour examination or pro rata basis) i) 30 minutes extra i.e. 2 hours for the subjects in which examination duration is 1 hour 30 minutes. ii) 20 minutes extra i.e. 1 hour 20 minutes for the subjects in which examination duration is 1 hour.
2	Presentation of Provisions (adjustment to the presentation of test material and / or test directions)	Allow the usage of a magnifying glass for Visually Impaired Candidates.
3		Verbal instruction for examinations to be written on blackboard of examination room
4		Clarification of examination directions, Colour naming (for students with colour blindness)
5		Provision of Access of sign language interpreters
6		Provision of Reader to read the question paper in case student with disability does not want scribe facility, and mentioning the guidelines for the same (limiting the role of the reader only for reading the paper, qualifications of the reader)
7	Response Provisions (adjustments to the manner in which students respond to or answer test questions)	Allow the usage of sketch pens for writing exams for Visually Impaired candidates.
8		Assistive devices permitted during the examination for disabled students
9		Provision of a scribe to write the answers/ interpreter

Sl No.	Classification of provision	Accommodations/Provisions offered by WBCHSE
10		Provide specific instructions regarding usage of a scribe (permission of changing the scribe, qualifications of the scribe)
11		Permission for the candidate to take the examination in a hospital under supervision
12		Permission for the presence of the caregiver inside the examination room during the examination.
13		Send the answer book of candidates with disabilities separately to the concerned office
14		Provide a relaxation in attendance upto 20% for candidates with disability who are unable to attend the school for prescribed days to qualify for writing the examination.
15		No Maximum Age Limit
16	Seating Provisions (adjustments in the environment in which the testing normally occurs)	Make arrangements for different rooms, chairs, table/bench etc for certain categories of disability (physical impairment, spastic students)
